# Seats are full for CECIMO's next "Additive Manufacturing and 3D Printing European Conference" at the European Parliament in Brussels

Brussels, 12 May 2016 – For the second year, CECIMO is organizing the "Additive Manufacturing and 3D Printing European Conference" at the European Parliament in Brussels (Belgium) on 25 May 2016 from 9.00 to 13.00. Building on the outcome of the first edition, the event now aims at going forward with creating a European strategy on additive manufacturing and 3D printing. The speed at which the seats filled in is proof of the importance to support the steady, long-lasting and consistent development of additive manufacturing in Europe. The event is co-hosted by five Members of the Parliament from four political groups: Dario Tamburrano (EFDD), David Borrelli (EFDD), Reinhard Bütikofer (Greens/EFA), Eva Kaili (S&D) and Andrey Novakov (EPP).

The speakers' session will tackle AM from the perspective of technology, markets, economic development and sustainability. During the session that follows, the panellists will debate on the different topics to be included in a European additive manufacturing strategy: from research to education, from IPR protection to SME development, from standardization to certification. As application fields rapidly expand from prototyping towards direct parts production, its transformative impact is being revealed in all areas of manufacturing: product design, production, supply chain organization, services and skills. CECIMO is the point of reference in the area of metallic based additive manufacturing for EU policy-makers. It works at ensuring that EU policies and regulations create the right framework conditions for the development of AM and contribute to boosting the competitiveness of the European industry as a whole. The first Additive Manufacturing European Conference was organised by CECIMO at the European Parliament in Brussels, Belgium in June 2015.
